

# Rebates on Qualifying Toilets



A High Efficiency Toilet (HET) uses approximately 20% less water than a standard toilet. This NEW program offers a **\$150** rebate on the purchase of a HET.

## How the Program Works:

A rebate of up to **\$150** will be provided Menlo Park Municipal Water District customers replace a toilet of 3.5 gallons per flush (GPF) or more with a High Efficiency Toilet (1.3 GPF or less).

## To qualify:

- The exact tank and bowl model number of the toilet purchased must be on the “List of Qualifying Toilets” for your water agency on the day of purchase.

- The HET must meet a minimum threshold of 500 grams on the Maximum Performance Testing procedure (MAP score).
- Toilets must be purchased between January 1, 2009 and June 30, 2009.
- A separate application must be submitted for each metered address.

## Who Can Participate:

**Residential** and **commercial** properties within the **Menlo Park Municipal Water District** are eligible. To verify your water district, please visit the following website:

## What to do next:

1. Purchase the toilet(s) between January 1, 2009 and June 30, 2009. Ensure that your home or business is part of the Menlo Park Municipal Water District.
2. Verify that the toilet is a qualifying model.
3. Complete an online application ([http://www.menlopark.org/departments/pwk/Brochure\\_Back.pdf](http://www.menlopark.org/departments/pwk/Brochure_Back.pdf)) or call the Menlo Park Engineering Division at 330-6740 for an application.
4. Ensure that the original receipt(s) are submitted with the application. If the receipt must be returned, please enclose a self-addressed, stamped envelope with your application.

## Program Limitations:

- All installations are subject to inspection prior to a paid rebate.
- Limit of **three** rebates per living unit, not per account; limit of **ten** rebates per commercial account.
- All sites are subject to post-installation inspection.
- Toilets used in new construction **DO NOT** qualify.
- Rebates are subject to availability of funds, and may take up to six weeks to process.
