Amendment No. 1
To
Go Pass Agreement

THIS FIRST AMENDMENT modifies the Go Pass Agreement (Agreement), which was effective January 1, 2020, between the Peninsula Corridor Joint Powers Board (JPB) and City of Menlo Park (Participant).

WHEREAS, the parties entered into the Agreement for the purposes of allowing Participant to purchase Go Passes for qualifying individuals; and

WHEREAS, due to the COVID-19 pandemic, the JPB has determined that it is in the parties' best interest to extend the expiration of the Agreement term from December 31, 2020 to March 31, 2021.

NOW, THEREFORE, the Agreement is hereby amended as follows:

1. The Agreement term is amended as follows: January 1, 2020 through March 31, 2021.
2. Except for those changes expressly specified in this First Amendment, all other provisions, requirements, conditions, and sections of the underlying Agreement shall remain in full force and effect.
