## AGREEMENT FOR SERVICES BETWEEN THE CITY OF MENLO PARK AND PUBLIC PARKING ASSOCIATES

THIS 1<sup>st</sup> AMENDMENT ("Amendment") is made and entered into this 1<sup>st</sup> day of July, 2017, by and between the CITY OF MENLO PARK, a Municipal Corporation, hereinafter referred to as "CITY", and PUBLIC PARKING ASSOCIATES, hereinafter referred to as "FIRST PARTY."

1. Pursuant to Section 4. COMPENSATION AND PAYMENT of Contract No. 2061 ("Agreement"), [amendment to section] to read as follows:

"CITY shall pay FIRST PARTY an all-inclusive fee that shall not exceed \$10,000 as described in Exhibit "A", Scope of Services. This compensation shall be based on the rates described in Exhibit "A". All payments, including fixed hourly rates, shall be inclusive of all indirect and direct charges to the Project incurred by FIRST PARTY. The CITY reserves the right to withhold payment if the City determines that the quantity or quality of the work performed is unacceptable."

2. Pursuant to Section 24. TERM OF AGREEMENT of Contract No. 2061 ("Agreement"), [amendment to section] to read as follows:

"This Agreement shall remain in effect for the period of July 1, 2017 through June 30, 2018 unless extended, amended, or terminated in writing by CITY."

Except as modified by this Amendment, all other terms and conditions of Contract No. 2061 remain the same.

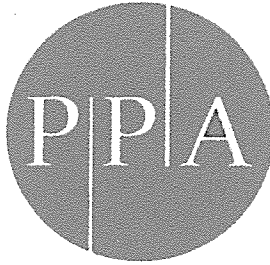

**PPA Maintenance Quote**

PPA offers preventative parking meter maintenance and offers on call services including the cleaning of sensors lubrication, application of protective coating, application of insecticide, replacement of batteries, and graffiti removal.

**For the parking program indicated:**

Service of 6 Parkeon multi-space pay stations located in two lots in Menlo Park. Service to include full preventative maintenance and repairs as needed. Service would not include collection or paper replacement.

**The following service is suggested:**

- One time service       Monthly service       Annual service

**Rate**

We offer simple One Rate Pricing that makes preventative maintenance costs predictable. Your rate covers all aspects of your meter support program including on site repairs and preventative service billed at :

- Non subscription rate \$125/hr       subscription rate \$65/hr

Subscription includes daily remote monitoring and provides 48 hour on call response times to all service requests. Subscription fees are \$65/unit per month

6 units x \$65 = \$ 390 Monthly

**Travel**

Due to often extensive travel times to the site we do not charge hourly rates for travel. Instead we charge a flat fee of \$50 per visit regardless of travel time.
