

<p>Remove approximately 25' x 34' of waterdamaged subfloor with maple flooring and dispose off site Dry concrete using fans as necessary Install subfloor with maple to match existing Sand only patch using medium and fine grits of sandpaper Please be aware there will be some dust you will need to clean up after we are through Apply one coat of Waterbase Seal Layout and paint gamelines that were sanded off Apply two coats of Waterbase Finish</p> <p><b>Work can be scheduled for week of August 19th</b> <b>Please allow 4 weeks to receive new flooring from time of order</b> <b>Please allow up to 1 week to complete job</b></p> <p>The floor may be walked on after 24 hours but the finish is susceptible to scuffing or maring during the first week. Finish is 80% cured in 24 hours, 90% in 72 hours and 100% in 7 days. Do not replace walk-off mats or clean with water or detergent during the first week.
